## Tewksbury Art Exhibition and Sale

Chairman Andy Calamaras has announced that the Tewksbury Historical Society will host its 29th Tewksbury Juried Art Exhibition and Sale Saturday, October 9 thru Saturday, October 16. The event will take place at the Zion Lutheran Church Christian Education Building, 16 Miller Ave., Oldwick, NJ with an Opening Reception on Friday evening, Oct. 8 from 6 to 8 pm. THS brings together the region's best fine artists and includes juried, small works, portfolio and photography.

Jurors of the Show will be Oscar Peterson, Judge of Selection, and Dannielle Mick, Judge of Awards. Awards will be "Best in Show", "Best of Tewksbury", "Marion Katnack Memorial Award", plus 1st, 2nd, 3rd place and Honorable Mentions in each category.

Submission deadline for Juried, Small Works and Portfolio is Sept. 17. Juried works must be original to the show, not having been submitted to any other THS Juried Art Exhibition. Categories are Natural Environment, Animal Kingdom, Still Life/Interiors, Florals, Abstract/non-objective and Built Environment. Works completed in any 2-dimensional media (including photography) may be submitted. No giclees allowed.
